

ALT TZ "Virtual ALT AZ Session 3" Sweepstakes – Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. When to Enter: The ALT AZ "Virtual ALT AZ Session 3" Sweepstakes ("Sweepstakes") will run from August 17, 2020, at 12:00:00 AM Mountain Time ("MT"), through September 12, 2020 at 11:59:59 PM MT ("Sweepstakes Period").

2. How to Enter: There are two (2) ways to enter:

i) Check-In w/ Mobile App: To enter via this method of entry, eligible listeners must register on the ALT AZ 93.3 Stream Player (the "App") at <http://www.ALTaz933.com> ("Website"). Once registered, visit your participating Bashas grocery store locations each day during the Sweepstakes Period to "Check In" to automatically receive one (1) entry into the Sweepstakes. Limit one (1) "Check-In" entry per person per day. All "Check-In" entries must be received by 11:59:59 PM MT on September 12, 2020 to be eligible for the random drawing. Sponsor is not responsible for telephone line unavailability, busy signals on the Sweepstakes line, operator interference, technical or atmospheric conditions that disrupt the completion of the entry, internet, app, Wi-Fi, or other technical malfunctions which may or may not result from this Sweepstakes.

ii) Website: To enter via this method of entry, eligible listeners visit www.altaz933.com, find the Sweepstakes mention on the Contest page of the Website. Once there, find, complete and submit the online entry form to receive one (1) entry into the random drawing. Limit one (1) entry per person per day via the online method of entry. All "Website" entries must be received by 11:59:59 PM MT on September 12, 2020, to be eligible for the random drawing.

3. How Winner is Chosen/Random Drawing: Then, on or about September 14, 2020, one (1) Grand Prize winner will be randomly selected from among all eligible entries received during the Sweepstakes Period. Sponsor will notify the potential Grand Prize winner by telephone or email and will make up to **two (2) attempts** to reach the potential Grand Prize winner. In the event Sponsor is unable to reach the potential Grand Prize winner after **two (2) attempts**, he/she will forfeit his/her right to be the Grand Prize winner and to receive the Grand Prize, and an alternate may be selected, time permitting, at Sponsor's sole and absolute discretion. The "authorized account holder" is the natural person assigned a phone number by an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Prize is non-transferable, not substitutable and not redeemable for cash. Sponsor may substitute the prize for one of equal or greater value for any reason. A 1099 form may be submitted to all appropriate taxing authorities. The prizes consist of only those items specifically listed as part of the prize. Participation Conditions/Release/Consent to use Likeness: By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize; and (d) allow Sponsor's use for promotional purposes of his/her likeness, voice and/or address (city/state) without any additional compensation.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner.

Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
