

## ALT TZ "MO'ments 2020" Sweepstakes – Official Rules

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.**

1. **When to Enter:** The ALT AZ "MO'ments 2020" Sweepstakes ("Sweepstakes") will run from December 8, 2020, at 12:00:00 AM Mountain Time ("MT"), through January 3, 2021 at 11:59:59 PM MT ("Sweepstakes Period"). The Sweepstakes Period will be broken out into three (3) weekly entry periods (each, a "Weekly Entry Pool") as set forth below, and one grand prize entry period. The grand prize entry period will coincide with the Sweepstakes Period ("Grand Prize Entry Pool").

2. **How to Enter:** There are two (2) ways to enter:

**i) Check-In w/ Mobile Apps Method of Entry:** To enter via this method of entry, eligible listeners must register on the ALT AZ 93.3 Stream Player (the "App") at <http://www.ALTAZ933.com> ("Website"). Once registered, visit your participating Quicktrip locations each day during the Sweepstakes Period where the "Holiday Green" specially marked Canada Dry, Squirt and 7UP w/ the RED CAPS are displayed, to "Check In" to automatically receive one (1) entry into the Weekly Entry Pool and one (1) entry into the Grand Prize Entry Pool simultaneously. Limit one (1) "Check-In" entry per person per day. All "Check-In" entries must be received by 11:59:59 PM MT on the End date listed in the Weekly Entry Pools Chart listed above, or by 11:59:59 PM MT on January 3, 2020 to be eligible for the Grand Prize Entry Pool's random drawing. Sponsor is not responsible for telephone line unavailability, busy signals on the Sweepstakes line, operator interference, technical or atmospheric conditions that disrupt the completion of the entry, internet, app, Wi-Fi, or other technical malfunctions which may or may not result from this Sweepstakes.

**ii) Text Keyword Method of Entry:** To enter via this method of entry, visit your participating Quicktrip locations each day during the Sweepstakes Period to find the keyword on the "Holiday Green" specially marked Canada Dry, Squirt and 7UP w/ the RED CAPS are displayed, ("Keyword"). Then, listeners must text the Keyword during the Sweepstakes Period to **68683**. Upon texting the correct Keyword, you will automatically receive one (1) entry into the random drawing (a "Text Entry" or "Entry"). All text entries must be received by 11:59:59 PM MT on the End date listed in the Weekly Entry Pools Chart listed above, or by 11:59:59 PM MT

on January 3, 2020 to be eligible for the Grand Prize Entry Pool's random drawing. Any entry that doesn't contain the correct Keyword, or that is sent after Sweepstakes Period will be disqualified and will not be eligible for the random drawing. Text message and data rates may apply. In the event of a dispute regarding the identity of the person submitting a mobile text entry, the entry will be deemed to be submitted by the person in whose name the mobile number is registered. The entrant may be required to provide evidence that the entrant is the authorized account holder of the mobile number associated with the winning entry and complete an affidavit and any applicable release. Limit one (1) entry per person per day via the text method of entry.

Any attempt by any participant to enter by using multiple/different identities, or any other methods may disqualify that participant from winning any prize, at the sole discretion of Sponsor. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different addresses, identities or registrations, or any other methods will void that entrant's entries and that entrant may be disqualified. Facsimile and mechanically reproduced entries will not be accepted. Sponsor is not responsible for lost, late, incomplete, illegible, invalid, unintelligible or misdirected Entries, which will be disqualified. In the event of a dispute as to any participation by an email Entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned a phone number by an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof that he/she is the authorized account holder. All entries submitted become the sole property of Sponsor and will not be returned. Entries will not be judged but must adhere to the entry guidelines indicated herein, as determined by Sponsor in their sole discretion.

- 3. How Check-In w/ Mobile App Winner Is Selected:** Then, on or about each Drawing date listed in the Weekly Entry Pool Chart in Official Rule #1, one (1) First Prize winner will be randomly selected from among all eligible entries received in that week's Weekly Entry Pool. All non-winning entries from any Weekly Entry Pool WILL roll over to subsequent Weekly Entry Pools. Odds of winning a First Prize depends on the number of eligible entries received in each Weekly Entry Pool. Then, on or about January 4, 2021, Sponsor will randomly select one (1) Grand Prize winner from among all eligible entries received in the Grand Prize Pool during the Sweepstakes Period. Odds of winning a Grand Prize depends on the number of eligible entries received during the entire Sweepstakes Period. Limit one (1) Prize per person during the entire Sweepstakes Period. Sponsor will notify each potential Prize winner by telephone or email and will make up to **two (2) attempts** to reach the potential Prize winner. In the event Sponsor is unable to reach the potential Prize winner after **two (2) attempts**, he/she will forfeit his/her right to be the Prize winner and to receive the Prize, and an alternate may be selected, time permitting, at Sponsor's sole and absolute discretion.

ARV: \$100.00 each. Winners shall be solely responsible for federal, state and local taxes. 6. **Participation Conditions/Release/Consent to use Likeness:** By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize; and (d) allow Sponsor's use for promotional purposes of his/her likeness, voice and/or address (city/state) without any additional compensation.

7. **General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. 8. **Limitations of Liability:** The Released Parties as set forth above are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited, to malfunctions, interruptions or disconnections in phone lines or

network hardware or software; (3) unauthorized human intervention in any part of the participation process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of phone calls; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any Prize.
