

ALT TZ "Ugly Sweater" Sweepstakes – Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. When to Enter: The ALT AZ "Ugly Sweater" Sweepstakes ("Sweepstakes") will run from December 2, 2020, at 10:00:00 AM Mountain Time ("MT"), through December 15, 2020 at 11:59:59 PM MT ("Sweepstakes Period").

2. How to Enter: To enter via this method of entry, eligible listeners visit www.altaz933.com ("Website"), find the Sweepstakes mention on the Contest page of the Website. Once there, find, complete and submit the online entry form, and then tell us what band or song you would like to see during our Ugly Sweater Virtual Festival on December 17th & 18th, 2020, to receive one (1) entry into the random drawing. Limit one (1) band or song entry per person during the entire Sweepstakes Period. All entries must be received by 11:59:59 PM MT on December 15, 2020 to be included in the random drawing.

3. How Winner is Chosen/Random Drawing: Then, on or about December 17th & 18th, 2020, during the Ugly Sweater Virtual Festival, twelve (12) winners will be randomly selected by Sponsor, from among all eligible entries received. Sponsor will announce the winners during the Festival and will also notify the potential winners by telephone or email the day of the Festival, and will make up to **two (2) attempts** to reach the potential winner. In the event Sponsor is unable to reach the potential winner after **two (2) attempts**, he/she will forfeit his/her right to be the winner and to receive the prize, and an alternate may be selected, time permitting, at Sponsor's sole and absolute discretion. Odds of winning depend on the number of eligible entries received during the Sweepstakes Period.

Any attempt by any participant to enter by using multiple/different identities, or any other methods may disqualify that participant from winning any prize, at the sole discretion of Sponsor. Use of any automated, robotic, repetitive, programmed or similar entry methods or agents to participate is prohibited and will result in disqualification. Participation Conditions/Release/Consent to use Likeness: By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize; and (d) allow Sponsor's use for promotional purposes of his/her likeness, voice and/or address (city/state) without any additional compensation.
